Our school is a comprehensive middle school that contains 6th-8th grade. We are currently in our ninth year of our AGS School Improvement Plan. We continue to strive for improvement by assessing and adjusting our goals. For example, adding a goal that addresses 6th-8th grade career preparation and readiness to our plan. Through program evaluations we have kept effective strategies and removed/replaced ineffective ones.

We also have in place a multi-tiered intervention system that assists the academic, behavioral, and social emotional issues facing our at-risk students. This system also helps to identify students that qualify for academic enrichment. Our students leave the middle school prepared and ready for high school. We strive to give our students a rich educational experience that promotes a sense of belonging in our greater community.

### **Core Curriculum**

Units of instruction in AGS core subjects are aligned with state content expectations, national standards, and common core standards. We currently follow the Common Core Curriculum in Math (Big Ideas) and ELA (Pearson MyPerspectives), the New Generation Science Standards, and the GIANTS curriculum in SS; these curriculum standards can be found on our district website.

### **Standardized Testing**

In the spring of each year, our students participate in state testing. During the 2020-21 school year the state required assessment accountability measure for 8th grade changed from M-Step for Math and ELA to PSAT. Since this was the first year this test was given in this capacity, no comparative data is available. ### **Parent-Teacher Conference Attendance**

Parents once again were strong contributors to the athletic programs, class functions, music boosters, and a great variety of other parent participation programs. Due to the increase in regular and ongoing communication between teachers and parents, there has been a slight decline in the percentage of parents involved at Parent Teacher Conferences. - Spring of 2019: 15%
